7 DAY BUSHFIRE EXCLUSION ENDORSEMENT

It is hereby agreed and declared that any cover under this policy or cover note in respect to damage arising out of or in connection with Bush Fire is suspended for a period of 7 days from the commencement date of this insurance or any additional cover which includes but is not limited to increases in sums insured or loss limits.

INFECTIOUS OR CONTAGIOUS DISEASES

This relates to the Business Interruption section of your policy. If your schedule shows that you have cover for infectious or contagious diseases, 'Policy B - ENDT(i) - (b)', with its attendant perils such as murder and suicide, is replaced by the following new clause.

Where this extension applies loss as insured by this Section B resulting from interruption of or interference with the Business directly or indirectly from:

- I. closure or evacuation of the whole or part of the Premises by order of any Government, Local Government or other Statutory Authority consequent upon:
 - a) human infectious or contagious disease occurring at the Premises;
 - b) vermin or pests or defects in the drains or other sanitary arrangements at the Premises;
 - c) the outbreak of a notifiable human infectious or contagious disease occurring at the Premises;
- II. poisoning directly caused by the consumption of food or drink provided on the Premises;
- III. murder or suicide occurring in or at the Premises;

shall be deemed to be loss resulting from Damage to property used by you at the Premises.

Cover under I(a) and I(c) does not apply in respect of Highly Pathogenic Avian Influenza in Humans or any other diseases declared to be quarantinable diseases under the Quarantine Act 1908 and subsequent amendments.

RETURN PREMIUM IN THE EVENT OF CANCELLATION

In the event that You cancel this policy prior to expiry, in accordance with the policy conditions. We will return the proportion of the Premium (less Our Commission and fees which are deemed to be fully earned at policy inception) which is equal to the proportion that the remaining policy period bears to the total policy period.
